With the aim of promoting European internationalization and offering students the possibility of personal and professional development, this offer of a practical training stay at the University of Cadiz is launched, in accordance with the lines of action of its strategic plan for internationalization.

The University of Cadiz is a public university located in the province of Cadiz, Andalusia, in southern Spain. Although officially established in 1979, the university can trace its origins back to the 15th century. UCA has four campuses located in four different cities of the province: Cadiz, Puerto Real, Jerez and Algeciras.

The province of Cadiz has a rich history which has left behind a remarkable imprint reflected in its streets, which you can explore while enjoying the wonderful climate.

The UCA is the coordinator of SEA-EU, the European University of the Seas - an alliance of 9 Universities (Cadiz, Brest, Kiel, Gdańsk, Split, Malta, Naples, Algarve and Nord) to establish a distinctly international, pluri-ethnic, multilingual and interdisciplinary European University.
